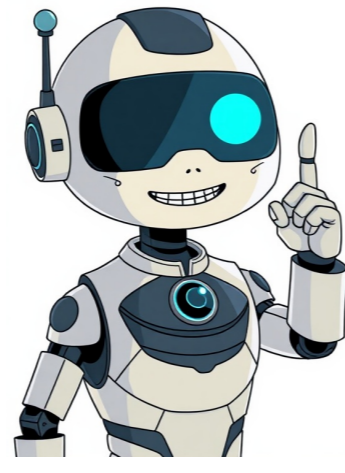


I'm not a bot
